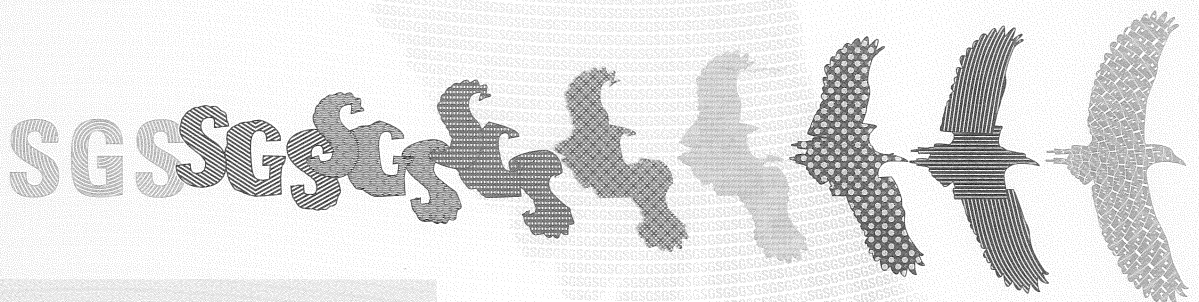

Respirex (logo) Limited Life SC1 Splash Suit, manufactured from 165g/m² barrier laminate on non-woven fabric (Respirex Part No. A00132). The suit is designed for use with a full face mask (not supplied) for respiratory protection of the user and has the following features: an integral neoprene grommet hood;. This garment is available in five nominal sizes and various design options for: sleeve terminations (S), leg terminations (L) and zip closures (Z), product code: SC1132H05S**L**Z**. Where ** is the relevant option code.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the requirements in the relevant harmonized standard:
